Some wood has been salvaged from Dave Tanner's residence (tornado aftermath) that can be used in addition to whatever other materials may be necessary. John Castro proposed we build overhangs to cover the window openings. Monte Stuhmer made a motion to spend up to \$200 for overhang materials for the clubhouse. John Castro seconded the motion. All were in favor. Motion carried.

Old Business:

- Regarding the possibility of the ASA shoot on May 1st, Gary or John will follow-up to see if they are still interested in conducting an ASA shoot at the Menard County Archer's range.

Other Business:

- The food and soda we have on hand should be okay for the next shoot with the exception of buns.
- Rick Price will send the top 3 scores to Larry Dale.
- The brush mower is in Tallula for repairs.

Rick Price made a motion to adjourn the meeting at 7:25 p.m.
