AGAIN FOR 2009

All initial applications for the Public Duck & Goose Hunting Area Permit program must be made via the internet, free of charge, accessible at www.dnr.state.il.us/duck OR www.dnr.state.il.us/goose. If you do not have a computer, see if a relative, friend or neighbor has one for you to use, or go to a Public Library. The phone-in procedure remains the same (see Application Dates).

Paper applications are no longer available.

Most questions regarding this application process can be answered by reviewing the information, instructions and hunting areas on this sheet.

Eliminating paper applications will help us issue more permits in a more timely fashion.

APPLICATION DATES

Internet applications from Illinois residents will be accepted as soon as the season dates are announced in late August for inclusion in random daily drawings beginning September 1 through September 14. Beginning September 29 unsuccessful applicants, non-residents and anyone that has not applied for or received a permit may call 217 524-6514 (8:30 A.M. - 4:30 P.M., Monday through Friday) to apply for remaining open areas and dates.

A second permit (for a different day than your first permit) may be obtained from unfilled quotas by calling 217 524-6514 (8:30 AM - 4:30 PM, Monday through Friday) beginning October 8.

APPLICATION INFORMATION

- Each applicant may apply for and receive only one duck permit AND one goose permit prior to October 8.
- If more than one application for a duck hunting permit or a goose hunting permit is received prior to October 8 in the same name, all applications will be rejected and permits revoked.
- A random daily drawing means all applications from one day are randomly processed before applications from the next day are randomly processed.
- Successful applicants will receive mail confirmation. • Permits are not transferable.
- Hunters under the age of 16 may apply for and receive a permit as long as they will be 16 by the day of the hunt. They must be at least 16 years of age at the time of the hunt for the permit to be valid to draw a pit, blind or staked site/area.
- Hunters applying for permits should understand that travel and transporting of all hunting equipment from designated parking areas to hunting locations and back may require walking a considerable distance.

APPLICATION INSTRUCTIONS

Duck application: You have 5 hunt area choices with 5 dates per hunt area. You may select the same area more than once to increase your date choices.

Goose application: Since there is only one goose area, you may have up to 25 date choices.

Your name, date of birth, mailing address and daytime phone number will complete the application process.

How to Fix Your Online Application Errors:

If you (1) made a mistake on any portion of your application (DO NOT REAPPLY), (2) mistakenly applied twice or (3) need to cancel an application please notify us as soon as possible - there are two ways to do this:

1. Email us at DNR.Permits1@illinois.gov - you will need to include your name, birthdate and a detailed explanation of what needs to be changed (example: please change my Hunt Area Choice from Union Co. to Horseshoe Lake).
2. Fax us at 217 782-5016 - on the receipt you printed out simply cross out the incorrect information and write the correct information next to it. Sign the receipt and fax it to us - Attn: Permit Dept. No cover sheet is needed.

- **BANNER MARSH F&WA**
(Fulton County)
5 mi. east of Banner on Rt. 24
- **BANNER MARSH F&WA DISABLED¹**
- **DOUBLE T SF&WA** (Fulton County)
9 mi. west of Canton, turn right on Co.Rd. 22H
Open every Wednesday, Saturday and Sunday.
- **MARSHALL SF&WA DUCK RANCH UNIT**
(Marshall/Putnam Counties)
East side of Illinois River, east and south of Henry and Rt. 18.
Open every Tuesday, Thursday, Saturday and Sunday.
- **RICE LAKE SF&WA WALK-IN UNITS** (Fulton County)
3 mi. south of Banner on Rt. 24
- **SANGCHRIS LAKE SUBIMPOUNDMENT**
(Christian County) 11 mi. southeast of Rochester
Accessible by boat only! 16' boat recommended;
25 HP motor limit.
Sangchris Lake Subimpoundment only, hunting is allowed on opening day, Tuesdays, Sundays (10 a.m. closing on Dec. 6) and the last day of the duck season. (On Thursdays (except closed Dec. 3) blinds will be allocated by a daily drawing at Sangchris Lake.)
- **SPRING LAKE SF&WA - Spring Lake Bottoms Unit**
(Tazewell County) 5 mi. northwest of Manito
Spring Lake SF&WA - Spring Lake Bottoms Unit - hunting is allowed on opening day and every Tuesday, Thursday and Sunday during the duck hunting season except the second Sunday in November which is closed due to the Youth Hunt.
- **UNION COUNTY SF&WA²**
On Rt. 3, 6 mi. south of Ware, turn east 1/4 Mi. at Reynoldsville
- **UNION COUNTY SF&WA DISABLED^{1, 2}**
- **HORSESHOE LAKE SF&WA²**
(Alexander County)
On Rt. 3, 12 mi. northwest of Cairo near Olive Branch
Union County and Horseshoe Lake will be closed Mondays and Tuesdays and December 24, 25, 26, and 27, 2009.
Union County and Horseshoe Lake will be open from the opening of the Southern Zone Duck Season through the Canada Goose Season and on December 27 when the site will be open for a special youth waterfowl hunt.

DUCK PARTNER & FEE INFO

A duck hunting permit holder is allowed to bring three (3) partners except at Rice Lake where a hunter can bring 2 partners and at Horseshoe Lake and Union County where a hunter can only bring one hunting partner and one non-hunting partner or 2 non-hunting partners. The permit holder must be present to hunt for the partners to hunt.

A \$10 daily usage stamp must be purchased at Banner Marsh, Marshall SF&WA Duck Ranch Unit, Sangchris Lake Subimpoundment, Spring Lake - Spring Lake Bottoms Unit, Union County and Horseshoe Lake. (Partners under 16 are free). No fee at Double T and Rice Lake.

- **SNAKEDEN HOLLOW** (Knox County)
On Rt. 167, 1 mi. east of Victoria
- **SNAKEDEN HOLLOW DISABLED¹**
Snakeden Hollow will be closed Mondays, Tuesdays, Wednesdays and December 24, 25 and 26, 2009.

GOOSE PARTNER & FEE INFO

A goose hunting permit holder is allowed to bring one partner. The permit holder must be present to hunt for the partner to hunt.

A \$15 daily usage stamp must be purchased at Snakeden Hollow. (Partners under 16 are free).

FOOTNOTES FOR DUCK & GOOSE

¹ One blind will be allocated, each day of the hunting season, to a disabled person. Successful applicants must present a State Disabled person I.D. card showing a P2, P2A, H2 or H2A disability, along with their permit, at the check station when they check in.

² Union County and Horseshoe Lake are now permit duck hunting areas. These areas have consistently been harvesting more ducks than geese during the past several years so they are now considered primarily duck hunting areas. The daily fee will be reduced to \$10 per person and hunters may still take geese in addition to ducks.

LICENSE INFORMATION

You must have a valid Illinois Hunting or Sportsman's License unless you are:

- A person who is disabled. A State disabled person I.D. card (available from the Secretary of State through the driver's license examining station) showing a P2, P2A, H2 or H2A disability.
- An Illinois Resident on active duty and on leave from the U.S. Armed Forces.
- A disabled veteran. A veteran's disability card (at least 10% service related); available from local Illinois Department of Veterans' Affairs offices.

Hunters born on or after January 1, 1980 must show proof that they have successfully completed the Hunter Safety Training Course provided by the Department or must show a previous year's hunting license.

WATERFOWL STAMPS

Unless exempt, hunters must possess both a Federal and State Migratory waterfowl stamp. Hunters under 16 years of age are not required to have a State or Federal stamp. Habitat Stamps are not required to hunt waterfowl.

ATTENTION MIGRATORY BIRD HUNTERS – You have to be H.I.P. in 2009

Registration with HIP (National Migratory Bird Harvest Information Program) is required to hunt migratory game birds in Illinois.

Do you hunt doves, ducks, geese, snipe, woodcock, coots or rails in Illinois? All **licensed** hunters must register with HIP if they intend to hunt migratory birds. It's free and it's easy.

HIP certifications are available at DNR Direct Automated License System agents, www.dnr.state.il.us or 1-888-6Permit. Lifetime licenses holders are automatically registered with HIP.
